This well was drilled during the second rig occupation on the Seltzer LD Pad.

Surface was set on the Seltzer LD 09-376HC on 4/4/2020. Activities were suspended on 4/4/2020, prior to reaching TD due to changing rig priorities. Great Western anticipates recommencing drilling in Q3 of 2021 with a large rig and plans to set production casing prior to completing the well in Q4 of 2021.

The TPZ and BHL footages are taken from the APD.

The depths are from the smaller surface rig and will change based on the production rig's KB on the final reports.

No logs were run on this well.
