On Tuesday 10/4/2022 at approximately 1300, I, Inspector Scott Ramsey, conducted a routine inspection at Genesis Fletcher Gulch 3-31, at Location # 311853 in Rio Blanco county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed well is not producing. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management.

During this inspection the following possible compliance issues were observed:

1. Tanks are lacking information.
2. Lack of battery signage.
3. Well head signage is lacking information.
4. No operator emergency number posted. 911 is posted.
5. Chemical tanks are lacking labeling and are not in containment.
6. Random debris.
7. Tank manway and random holes are open for wild life to enter.
8. Stored equipment.
9. Buckets and barrel full of unknown fluids.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
