This Warning Letter is to inform you that CRESTONE PEAK RESOURCES OPERATING LLC (“Operator”) may be in violation of the rules and regulations of the Colorado Oil and Gas Conservation Commission (“COGCC”) and corrective action is required.

COGCC has reasonable cause to believe that Operator has committed one or more violations of the Oil and Gas Conservation Act, or of a rule, regulation, or order of the Commission, or of a permit issued by the Commission. Operator is required to comply with this Warning Letter by the **Corrective Action Deadline Date(s)** to resolve the alleged violation(s). Failure to do so will result in the issuance of a Notice of Alleged Violation and initiation of enforcement proceedings in which COGCC will seek monetary penalties for the alleged violations pursuant to § 34-60-121, C.R.S. and Rule 525, COGCC Rules of Practice and Procedure, 2 CCR 404-1.

Description of Alleged Violation: Operator closed an Oil & Gas Facility in preparation for upgrading equipment (see Sundry Notice - Form 4 #402842170) at the subject location. Operator did not submit a Site Investigation and Remediation Workplan (Form 27) for COGCC review and approval prior to closing the pre-existing facilities.

Required Corrective Action: Operator shall submit an Initial Form 27 for COGCC review and approval.
