INITIAL ACTION SUMMARY

Description of initial action or emergency response measures taken to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the SANDAU 34-12F wellhead cut and cap and flowline abandonment. Approximately 490' of flowline was abandoned-in-place. The wellhead was cut and capped per COGCC rules.

One (1) grab soil sample was collected at the wellhead excavation. The wellhead soil sample was analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron. One (1) waste characterization sample for COGCC Table 915-1 metals was collected.

One (1) grab soil sample was collected at the flowline terminus. The flowline soil sample was analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron.

All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

A site assessment will be scheduled to delineate impacted media identified at WH-FS-01 @ 6'. Chevron proposes soil samples will be collected adjacent to WH-FS-01 for analysis of TPH (C6-C36), organic compounds in soil per COGCC Table 915-1, and arsenic.

If groundwater is encountered during the subsurface assessment, each soil boring will be completed as a monitoring well and the groundwater will be sampled for BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, 1-methylnaphthalene, and inorganic parameters.
