Comment:

There is a remediation project #19874 currently in process at the location. The location has been recontoured and soils appear to have been decompacted. It does not appear seeding has occurred yet. Reclamation and seeding will need to be completed by the current fall season. A fence has been constructed around the location to prevent livestock entry and will need to be maintained. There is a pipe riser found at the northwest side of the location that needs to be removed. The location remains out of compliance until all reclamation is completed.

There has been gravel applied to areas of the road where issues were previously observed. At the time of inspection the road appeared to be stabilized.

There are wattles installed at the east side of the location however, the wattles are not properly staked down. The wattles will need to be properly staked down once the location is seeded and reclaimed this fall season. Once the location is seeded, soils should be further stabilized.
