This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 02/04/2019. During this inspection it was observed that all oil and gas equipment identified in previous inspections has been removed. The access road and location have not been contoured or regraded, and the disturbed areas have not been revegetated with evidence of bare soil. The location and associated access roads are not reflective of reference area levels. Refer to attached inspection photos.
