To Whom It May Concern:

Kerr-McGee Oil & Gas Onshore LP is applying for a permit to drill for the captioned horizontal wells below. Pursuant to Rule 408.t, you are being provided notice proposed wellbores lying within one hundred fifty (150) feet of the existing active well cited below. Additionally, pursuant to Rule 408.u, no portion of a proposed wellbore's treated interval shall be located within one hundred fifty (150) feet of an existing (producing, shut-in, or temporarily abandoned) or permitted oil and gas wellbore's treated interval belonging to another operator without the signed written consent of the operator of the encroached upon wellbore.
