Comment: The well location and access road appear to meet final reclamation regulations and standards, and appear reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances.

The tank battery does not comply with Rule 1004. Majority of the tank battery disturbance has a high density of kochia and does not appear consistent with adjacent corner crop areas.
