Trash/debris/old equipment remains on Location including a road culvert to the north, perimeter fencing, the wellhead sign, and some metal trash/debris. Inspector piled trash at wellhead sign for easy removal. The southern portion of the perimeter fence is a pasture fence and does not require removal.

At the time of this inspection this Location is progressing towards 1004 vegetation standards; perennial grasses are well established.

Corrective Action: **Comply with 1004.a. Remove all trash/debris/equipment including the perimeter fence, culvert, wellhead sign, and metal debris.**
