Location #335320 in Garfield County Colorado. While there, I observed normal production operations. During this inspection the following compliance issues were observed:

- 1) Chemical tank missing required information with a corrective action date of 11/12.22.
- 2) Heating insulation open ended and not capped with a corrective action date of 10/19/22.
- 3) Unmarked Deadman with a corrective action date of 10/19/22.

- Location is located in a high priority habitat area.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
