Comment This inspection was to document the scope of reclamation work that has been performed since the previous inspection. COGCC Staff met with a KPK Contractor and surface owners.

Operator has recontoured, seeded and hydromulch all disturbance areas. Germination of desirable plant species was observed throughout much of the reclamation areas.

Operator shall continue to monitor and manage this site until the location meets Rule 1003 standards, including stormwater and weed management. Operator shall submit a Form 4 Interim Rec. Complete notice when the location meets Rule 1003 standards. COGCC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1003.
