Comment This location does not comply with Rule 1003. During this inspection, COGCC Staff observed annual weedy vegetation (kochia) throughout the interim areas. Some desirable vegetation (buffalo grass, blue grama) was also observed in portions of the interim reclamation areas. The weedy vegetation is slowing progress towards interim reclamation standards. Refer to attached inspection photos.

Corrective Action Perform reclamation in accordance to Rule 1003. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards.
