Additional BMP's also should be installed at the tank battery location to prevent sediment movement into the vegetation shown at photo 5. The berms around the impacted soil piles have been constructed larger but were not compacted. A liner should have been used underneath the impacted material storage. Additional BMP's need to be installed.</p>
