There are also concerns of soil issues due to areas bare of vegetation where former pit was located. The soil and gravel were not removed/leveled at the pumpjack and there is oil stained soils at this area that need to be cleaned up. All reclamation should have been completed within 3 months of abandonment. Corrective action must be performed immediately to obtain compliance.**
