Spotted 30 sack cement plug f/5492-5454', 10 sack cement plug f/91-54', and 10 sack cement plug f/27' to surface. Welded 1/4" steel plate on top of surface casing 18" below ground level. Completed, plugged, and abandoned dry hole as of 12 Noon 8-30-68. All equipment has been removed from the well and the location cleaned and leveled.
