INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the HSR-CHARLTON 08-20 wellhead cut and cap and flowline removal. Approximately 80' of flowline will be removed. The COGCC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead will be cut and capped per COGCC rules. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

Seven grab soil samples were collected for analysis by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

The source was delineated through an environmental site assessment. An excavation to remove impacted soil will be scheduled prior to January 25, 2023. Noble proposes to remove barium from the previously approved sampling plan (refer to COGCC document number 402950642) and limit the analysis of remedial excavation confirmatory samples to TPH (C6-36) and organic compounds in soil per COGCC Table 915-1.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Based on the results of the background samples collected on 8/26/2022, elevated barium is present in native soils adjacent to the site at concentrations similar to or higher than those observed in the source area. As such, Noble proposes to remove barium from the previously approved sampling plan (refer to COGCC document number 402950642), and limit the analysis of remedial excavation confirmatory samples to TPH (C6-36) and organic compounds in soil per COGCC Table 915-1.

Based on the lack of detections of BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, 1-methylnaphthalene (1-M), and 2-methylnaphthalene (2-M) in groundwater samples, Noble proposes to remove the impacted soil through a remedial excavation and discontinue quarterly groundwater monitoring following source removal. Pending the receipt of compliant excavation confirmatory sampling results, Noble will request a No Further Action (NFA) designation for the Site from COGCC. Following NFA approval by the COGCC, Site reclamation will be completed in accordance with COGCC Rule 1004.
