**General Comment:**

COGCC Environmental Inspection, follow-up to Operator's Form 19 Spill/Release reports for Spill/Release ID #479684. Weather conditions during inspection were cloudy with a temperature of 30 degrees Fahrenheit.

On inspection date, areas surrounding the reported Spill/Release location were observed for potential impacts relating to Spill/Release ID #479684. No signs of potential hydrocarbon impacts were witnessed in the area. See attached photos.



**Environmental****Spill/Remediation:**

Comment: Operator's Supplemental F19 (doc #402647811, dated 4/4/2021) indicates that this spill/release was discovered on 3/25/2021 and reports a gas odor with dead vegetation at the point of release and that excavation samples were collected as of the report date. The report also documents impacts to soil measuring approximately 40 feet by 8 feet by 8 feet. No supplemental reports have been received by the COGCC and the Spill/Release retains ACTIVE status.

Per Rule 912.b.(6), "No later than 90 days after a Spill or Release is discovered, the Operator will have submitted and obtained the Director's approval of either" a Supplemental Form 19 requesting CLOSED status or an Initial Form 27 to document ongoing Site Investigation and Remediation requirements.

Corrective Action: **Immediately submit a Supplemental Form 19 to document clean up per Rule 912.b.(6).A or an Initial Form 27 for additional remediation per Rule 912.b.(6).B.** Date: 06/23/2021
