Comment: The well location and access road appear to meet final reclamation regulations and standards, and appear reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances.

The tank battery location does not comply with Rule 1004. Majority of tank battery shows stunted crop growth. Site investigation into why the crops are stunted is required.

Corrective Action:	<p>Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
