On Monday 10/31/2022 at approximately 1100, I, Inspector Scott Ramsey, conducted a follow up inspection at TEP North Bank E, at Location # 336017 in Garfield county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.

C/A's (Missing plugs and tank labeling) from previous inspection document # 700704161 has been completed. C/A (stored equipment) from previous inspection document # 700704161 has not been completed. Therefore C/A date remains the same.

During this inspection the following compliance issues were observed:

1. Stored equipment from previous inspection is still stored on location C/A date 6/24/2022
2. Cellars open for wildlife or personnel to fall into and are full of fluid.
3. Random debris
