Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1004 standards.

Final reclamation activities shall be complete no later than 5/1/2023 or as soon as environmental conditions will permit, which could include a Fall 2022 seeding.
