On Thursday 10/27/2022 at approximately 1100, I, Inspector Scott Ramsey, conducted a follow up inspection at TEP RMV 239-29, at Location # 324112 in Garfield county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.

C/A from previous inspection document # 700702544 has not been completed.

During this inspection the following compliance issues were observed:

1. Access to location shows signs of lack of stabilization and tracking onto county road.

2. Well sign is lacking API #
