During tank battery dismantlement historical impacts were discovered in the vicinity of the produced water vessel. Remediation of impacted media will be scheduled.

Five initial grab soil samples were collected by Eagle Environmental and submitted to Origins Laboratory for analysis of TPH-DRO by EPA Method 8015, TPH-GRO, BTEX, and Naphthalene by EPA Method 8260c. Additionally, SS-03@3' was analyzed for EC by Modified 9050A, SAR by 20B Saturated Paste, and pH by EPA 9045D. During subsequent investigation and excavation activities fifteen grab soil samples were collected and analyzed for TPH-DRO by EPA Method 8015, TPH-GRO, BTEX, and Naphthalene by EPA Method 8260c. EX-SS-01, EX-SS-02, and EX-SS-03@3' were also analyzed for SAR by 20B Saturated Paste.
