It has come to my attention today, through an email from my HOA, that the company Civitas is planning to frack and extract resources from right under our houses and our previous water supply, the Aurora Reservoir. I attached an image of the apparent proposal.

When I got the news, I was completely stunned and devastated. My husband and I were in tears. We love our home. We have put so much time and effort into creating a space that we love. It's extremely alarming and shameful the city of Aurora would allow fracking to happen so close to an important water supply, the Aurora Reservoir. It's also appalling that the council thinks it's okay to frack under communities filled with children, schools, etc. There is plenty of evidence demonstrating the dangers of being in proximity to fracking wells. I read an article of even Governor Polis himself trying to stop fracking near one of his homes. I am shocked that the city would be so negligent to risk making its residents sick and tainting our water supply, especially in times of drought and scarcity of water. It's completely unacceptable. To say we are upset is an understatement.

We moved into this community just a little over a year and a half ago with good intentions and pride of living in this city. We were drawn to this community, Southshore, for its wealth, beauty, nature, and school district. Why on earth the city would pick this location to frack is beyond comprehension. If Aurora is trying to get people drawn to their city, this is a sure awful way to do it. I regret giving Aurora the benefit of the doubt when people warned me about it. Also, why is Aurora, to my understanding, asking for clients to come in and drill? Drilling near one of your affluent neighborhoods? Is there not enough space out east to drill away from homes?

We are extremely concerned, not just for our health, but also over the implications for our property's value.

We also feel duped. This community is still being built with new homes. I would have never purchased here if I knew they'd frack so close to homes. Toll Brothers assured us this would not happen. Terrible. Many of my neighbors just established here and are now having their lives turned upside down.

I have already reached out to a realtor to get their opinion. If this is approved we will be relocating out of Aurora for good. I will have regret choosing Aurora as our home. Shame on the city for putting profits over people. There's no humanity in that. I don't know how the council sleeps at night, because I certainly can't.
