Following facility decommissioning operations at the Berry Farms 30 31 32-8HZ O SA location on October 31, 2022, 14 confirmation soil samples were collected from the former separators. Soil Sample SEP-B05@3" was submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene (TMB), 1,3,5-TMB, total petroleum hydrocarbons (TPH) - gasoline range organics (GRO: C6-C10) by United States Environmental Protection Agency (USEPA) Method 8260D, TPH - diesel range organics (DRO: C10-28) and oil range organics (ORO: C28-C40) by USEPA Method 8015D, pH, specific conductance (EC), sodium adsorption ratio (SAR) by saturated paste method, and boron by hot water soluble soil extract method. Preliminary analytical results received on November 2, 2022, indicate that the naphthalene concentrations in soil sample SEP-B05@3" exceeded the COGCC Table 915-1 Cleanup Concentrations. Excavation and assessment activities are ongoing and will be summarized in a forthcoming quarterly Form 27- Supplemental Site Investigation and Remediation Workplan under Remediation Project No. 25564 (approved Form 27 Document No.403185605). A topographic Site Location Map showing the geographic setting of the release is provided as Figure 1. Field notes and a photographic log are provided as Attachment B. The State Notification email is provided as Attachment C.
