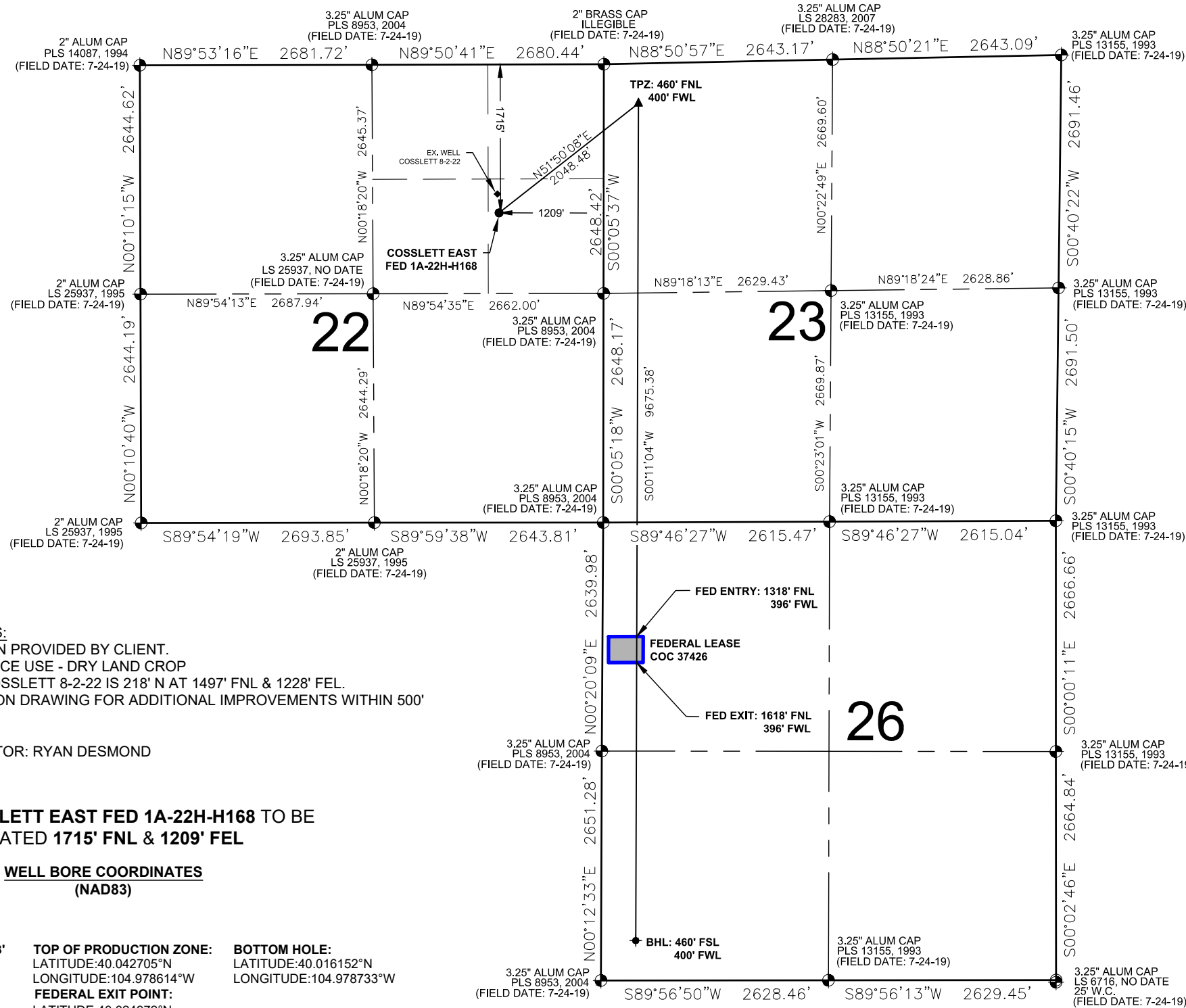


COSSLETT EAST FED 1A-22H-H168
