Remove and properly dispose of debris deposited on well pad and around facilities. Submit (as an attachment to a Form 4) and implement a plan to properly divert and protect the location from degradation during significant stormwater events on the well pad using good engineering practices. All inlets and outlets need to be properly designed and constructed to ensure stabilization. Corrective action date is the day of the inspection (7/29/2021) as it is required that the corrective action be addressed immediately.
