Comment:

The well location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged on 3/20/2017. Canada thistle was observed flowering at the location.

The tank battery appears to meet final reclamation regulations and standards, and appears reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances.

Corrective Action:

Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production. Provide documentation within the FIR Resolution form of when the corrective action work will be completed and provided date and documentation of coordination with the surface owner.

The corrective date is not intended to be the date for which the Operator shall complete the corrective actions but rather the corrective date is the date the location was observed out of compliance.
