**General Comment:****COGCC Inspection Report Summary**

On Monday 11/7/22 at approximately 12:30 hours, I, Inspector Corey De Paolo, Conducted an on-site inspection at TEP ROCKY MOUNTAIN LLC UNOCAL-67S96W /1NWSE. Location #324063 in Garfield County Colorado. While there, I observed normal production operations. During this inspection the following compliance issues were observed:

- 1) Battery sign weathered and not legible with a corrective action date of 12/7/22.
- 2) Loadline open ended with a corrective action date of 11/14/22.
- 3) Location lacks stabilization. Insufficient tracking BMP at entrance to location with a corrective action date of 11/22/22.

- Location is located in a high priority habitat area.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
