INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to summarize assessment activities conducted during the plugging and abandonment of the Webber 17-3 wellhead and the permanent removal of the associated off-location flowline. Assessment activities began on January 3, 2022. Soil assessment activities were conducted in accordance with COGCC Rule 911.a. A photo log is attached.

On January 3, 2022, soil samples were collected from the wellhead excavation and flowline potholes. The samples were field screened for total volatile organic compounds using a photoionization detector (PID). One base sample from the wellhead excavation and one flowline pothole sample were submitted for analysis. Based on PID readings from the wellhead excavation and potholes, no additional soil samples were submitted for laboratory analysis. Analytical results indicated soil was in full compliance with Table 915-1 standards. Therefore, further excavation was not warranted. The excavations and flowline potholes are depicted on Figure 1 and Figure 2. The soil sample results and PID readings are summarized in Table 1 and Table 2, respectively, and the laboratory report is attached.

Following cut and cap operations, a soil gas survey was conducted. Five soil vapor points were installed adjacent to the former wellhead location. GEM 5000 field readings were all non-detect for methane at all soil vapor points. The soil vapor point locations are illustrated on Figure 1. The soil vapor field form is included as an attachment.
