Inside secondary containment, the temporary tanks were removed and 33 yards of impacted fill material was disposed at a licensed landfill. The liner was visually impacted and was determined to not be compromised. Due to operational constraints, some impacted fill material was left in place. Sample were collected and submitted for Table 915-1 analysis. The impacted fill material will be treated in-place and analyzed in the future to confirm treatment was successful.
