	<p>The well location and access road appear to meet final reclamation regulations and standards, and appear reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances.</p> <p>The tank battery does not comply with Rule 1004. Western portion of the tank battery shows stunted growth and does not reflect the reference areas. Site investigation into why the crops are stunted is required.</p>	
Corrective Action:	<p>Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
