INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to summarize assessment activities conducted during the closure of one produced water vessel (PWV) at the Badding Tank Battery/20-26SX facility. The PWV was permanently removed. Assessment activities began on July 29, 2022. Soil assessment activities were conducted in accordance with COGCC Rule 911.a. A photo log is included as an attachment.

On July 29, 2022, soil samples were collected from the PWV (see Figure 1). The soil samples were field screened for total volatile organic compounds using a photoionization detector (PID). One soil sample from the base and one sample from the northern sidewall of the excavation were submitted for laboratory analysis. Based on PID readings, no additional soil samples were submitted for laboratory analysis. Analytical results indicated soil was in full compliance with Table 915-1 standards or within the analytical variability of the background sample at the extents of the excavation. Therefore, additional excavation was not warranted. The PID readings and soil sample results are summarized in Tables 1 and 2, respectively. The laboratory report is attached.

One tank battery background soil sample (TB-BG01@0.5') was collected for laboratory analysis of specific conductivity (EC), sodium adsorption ratio (SAR), pH, boron, and metals. Laboratory analytical results indicated that arsenic is naturally high in the soil used to construct the tank battery.
