This Supplemental Form 27 is being submitted to provide facility closure documentation pertaining to the Vision Energy USA 1-22C location (previously operated under Maralex Resources). This well was not ever completed. No equipment was on location with the exception of the wellhead.

As outlined within the approved Initial Form 27, a sample was collected at the wellhead. The initial sample was taken on the same day that the well was cut and capped and right up against the cement that was in the hole. The initial sample showed a very high SAR level. The cement was removed and a new sample was taken from the same sample location at a later date. The results from second sample indicate that all the soils satisfy COGCC Table 915-1 thresholds.

Vision Energy is requesting closure of the USA 1-22C location and approval to proceed with final reclamation.
