	<p>This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 12/22/2010. During this inspection, COGCC Staff observed that there was an area approx. 20'x30' of gravel/road base that has not been removed. Several areas identified on location have failed to revegetate and reflect reference areas with uniform vegetation cover, and undesirable weedy vegetation (e.g. kochia) was observed in portions of the location. Refer to attached inspection photos for additional information.</p>	
Corrective Action:	<p>Comply with Rule 1004. Operator shall remove gravel/road base and reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p> <p>Corrective action date is the date the location was observed out of compliance.</p>	Date <b>11/16/2022</b>
