**This Warning Letter is to inform you that OWN RESOURCES OPERATING LLC (“Operator”) may be in violation of the rules and regulations of the Colorado Oil and Gas Conservation Commission (“COGCC”) and corrective action is required.**

COGCC has reasonable cause to believe that Operator has committed one or more violations of the Oil and Gas Conservation Act, or of a rule, regulation, or order of the Commission, or of a permit issued by the Commission. Operator is required to comply with this Warning Letter by the **Corrective Action Deadline Date(s)** to resolve the alleged violation(s). Failure to do so will result in the issuance of a Notice of Alleged Violation and initiation of enforcement proceedings in which COGCC will seek monetary penalties for the alleged violations pursuant to § 34-60-121, C.R.S. and Rule 525, COGCC Rules of Practice and Procedure, 2 CCR 404-1.

### Alleged Violation(s) and Required Corrective Action(s):

418 Form 21, Mechanical Integrity Test

Violation Date: 05/06/2022

Violation Discovery Date: 11/29/2022

Description of Alleged Violation: Operator is receiving this letter because, based on COGCC records, COGCC has reason to believe the Well(s) indicated above and/or in the attached table presents one or more compliance issues. Operator should review its records to verify if any Forms or Notices related to mechanical integrity test (“MIT”) are outstanding for this Well.

Pursuant to Rules 418 and 405.n., Operator is required to notify COGCC of intent to perform MIT by submitting Form 42 Notice of Mechanical Integrity Test (“Form 42 MIT”) at least 10 days prior to the performance of such test.

If Operator performed a mechanical integrity test and failed to submit Form 42 MIT at least 10 days in advance of the test date, Operator violated Rules 418 and 405.n.

Required Corrective Action: Operator shall submit any delinquent forms, notices, or reports. Operator shall send an email to the COGCC Representative indicated below, detailing an internal procedure for timely compliance with Rules 418 and 405.n. Operator shall reference this Warning Letter document number in the subject of the email.
