Comment:

Inspection #696204104 documented that the Location received an approved 502.b SOVR (Doc #401809327) to waive reclamation requirements of the access road, and a partial reclaim of the Location. Inspection observed that the Location has achieved 1004 revegetation standards, however Noxious Weeds and the perimeter fence remained.

Inspection directed Operator to conduct additional weed management, and to remove the fence, and to submit photo documentation attached to a FIRR showing weeds/fence have been removed.

Operators submitted FIRR #403239314 with the required documentation; CA has been resolved. Operator has met all final reclamation obligations.
