INITIAL ACTION SUMMARY

Description of initial action or emergency response measures taken to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to summarize assessment activities conducted during the plugging and abandonment of the Mayer 22-10L wellhead and the permanent removal of the associated flowline. Assessment activities began on December 21, 2021. Soil assessment activities were conducted in accordance with COGCC Rule 911.a. A photo log is attached.

Between December 21, 2021 and April 15, 2022, soil samples were collected from the wellhead excavation, flowline potholes, and separator riser. The samples were field screened for total volatile organic compounds using a photoionization detector (PID). One soil sample from the base of the wellhead excavation was submitted for analysis. Based on PID readings from the wellhead excavation and potholes, no additional samples were submitted for analysis. Analytical results indicated soil was in full compliance with Table 915-1 standards. Therefore, further excavation was not warranted. The excavations and flowline potholes are depicted on Figure 1 and Figure 2. The soil sample results and PID readings are summarized in Table 1 and Table 2, respectively, and the laboratory reports are attached.

Following cut and cap operations, a soil gas survey was conducted. Five soil vapor points were installed adjacent to the former wellhead location. GEM 5000 field readings were all non-detect for methane at all soil vapor points. The soil vapor point locations are illustrated on Figure 1. The soil vapor field form is included as an attachment.
