<p><b>COGCC Inspection Report Summary</b>  On Friday 12/2/2022 at approximately 09:30 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the KPK Bernhardt 7-16 API #123-22698 in Weld County, Colorado.</p> <p>While there, I observed unused equipment on location and that the wellhead master valve was leaking with stained soil around the wellhead. During this inspection the following possible compliance issues were observed: Rule 606. with a corrective action date of 12/30/2022, Rule 608.e. with a corrective action date of 12/30/2022.  A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
