Mr. Miller,

Prior to commencing completion operations on the Anschutz Equus Farms 4-62-21 NESE Pad, the Colorado Oil and Gas Conservation Commission ("COGCC") is requiring HighPoint Operating Corporation (HPOC) to re-plug the Orr 14-20 Well (API No. 05-123-09247 and Orr 1 Well (API No. 05-123-05137) (the "Offset Wells"). The Offset Wells were previously abandoned on surface owned by Equus Farms Inc. according to applicable records. The COGCC policy requires HPOC to obtain the consent of the surface owner for the operation either through the existence of a surface use agreement or a specific consent if there is not an applicable surface use agreement. In the case of the Offset Wells, there is no applicable surface use agreement. Therefore, HPOC is requesting your written consent to the re-plugging operation for the Well.

In addition and pursuant to rules 412.a.(4) and (5) of the COGCC rules governing subsequent well operations, HPOC hereby gives its seven (7) day notice before use of heavy equipment for the re-plugging operations and the thirty (30) day notice of final reclamation operations to follow the re-plugging and abandonment of the Offset Wells.

Once the re-plugging operation commences, HPOC's contractor should be on location for approximately 5-10 days per well, weather permitting. If you request, a representative from HPOC will be available to meet and consult with you about the re-plugging operation. If you prefer, you can appoint an agent by providing HPOC with the name, address and phone number of the agent.
