Comments: 30 days of first sales - high pressure follow-up. 229 PSI mud and gas flow blew down to 0 PSI within 5 minutes. Mud on open, produced ~1.5 gallons and died to drip, 2 gallons total. PDC collected 40mL sample and will submit results via form 43. PDC will monitor pressure and re-test according to bradenhead policy.
