On November 22, 2022 COGCC OWP Western Region EPS Jim Hughes conducted an environmental field inspection of the Laramie Energy LLC Spill/Release Point ID #483326. Laramie and Entrada representatives were on site during this inspection. Refer to Initial Spill/Release Document #403238574 for more information regarding this release. During this inspection a Laramie representative provided an overview of the impacted area and initial spill response measures conducted. Water trucks and heavy equipment were actively working during this inspection. A containment berm was being constructed around the majority of the impacted area within the field. The spill originated from a valve can near the northeast corner of the Gunderson 20-03 pad. Released fluids flowed into storm water BMPs where it ultimately breached a diversion ditch and flowed across a field and into Buzzard Creek. No sheen was observed within the creek. Booms had been deployed across the creek. Soil and water samples had reportedly already been collected.	hughesjo	11/30/2022
