Comment: This location does not comply with Rule 1004. It appears the operator has performed final reclamation activities as it was observed that the location and access roads have been contoured and graded to reflect reference areas. However, it was also observed that large areas of non-uniform vegetation cover resulting in bare soil are evident and undesirable vegetation (e.g. russian thistle) and debris (e.g. netting) were observed throughout the location. Refer to attached inspection photos for additional information.

Corrective Action:	Comply with Rule 1004. Operator shall remove debris and reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.
