The failed inspection notes that "it appears reclamation work has been preformed at this location, however, the reclaimed area is not reflective of the crop reference area. Vegetation is stunted possibly as a result of compaction and portions of the access road have not been reclaimed. Please see the attached photos and invoices showing that the lease road had in fact been reclaimed in October of 2020. I am not sure what I can do about the farmer driving where he wants on his own land. Please also see the attached invoice and letter from Parachini Pastures showing that the land owner preformed work and hauled in dirt on the location after I had finished our final reclamation work. I agreed to pay for 1/2 of this work in an attempt to be a good neighbor. On 10/12/22 I spoke with Jack and Dick Parachini with Parachini Pastures and they asked that we wait until March (depending on weather they might want to wait) to re rip the ground or preform any other reclamation work and he also said he did not want the culvert or entrance to the field removed.
