Comment:

To address concerns regarding the discrepancies in the permitted disturbance (13.73 acres) listed on the original Form 2A (Doc 401189323) versus actual (15.21 acres). Please review the attached location drawing (Doc 402980443) and approved Form 4 (Doc 403067544) both of which were submitted on 3/10/2022. The approved sundry specifically calls out the updated location drawing in the Operator Comments. While the change was not directly requested on the sundry, it is Axis' opinion the change in permitted disturbance was adequately conveyed

to the COGCC via the location drawing and details provided in the Operator Comments.  
Please note this location was originally permitted under Bison Exploration and was later acquired by Axis. The approved Form 2A (Bison) has the disturbance listed as 13.73 acres, but the associated location drawing indicates 15.18 acres of disturbance. This was the source of the confusion and the issue was communicated with the COGCC Reclamation team on August 24, 2022.
