Comment:

Inspection #692402017 observed that reclamation was not complete, and required Operator to comply with 1004 rules.

It was observed in this inspection that the overall status for reclamation on the location is "In Process"; limited vegetative assessment due to weather conditions, however there are areas around the wellsite, and the former facility location where vegetation appears to be predominantly undesirable, or annual plant species. Additional reclamation work will likely be required to ensure the site progresses towards 1004 standards. Noxious weeds, such as knapweed and chicory were also observed in patches around the Location and access road; weed management required until site receives a passing final reclamation inspection.
