INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the GUTTERSEN D09-09 wellhead cut and cap and flowline removal. Approximately 800' of flowline was removed and approximately 100' of the flowline was abandoned-in-place due to field constraints. The wellhead was cut and capped per COGCC rules.

Three (3) grab confirmation soil sample were collected at the wellhead excavation (1), flowline change of direction (1), and flowline terminus (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
