Comments: 30 days of first sales - high pressure follow-up. 53 PSI water on open, produced 1 quart and died for several minutes. Water drips started again shortly after 5 minute mark. Collected 1000mL water sample. Water drip for duration of test, produced ~ 1/2 gallon of water total. PDC will monitor pressure and re-test according to bradenhead policy.
