Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the LILLI UNIT 4-17 wellhead cut and cap and flowline abandonment. Approximately 2265' of flowline was abandoned-in-place. Form 44 Doc # 403005982. The wellhead was cut and capped per COGCC rules.

A grab confirmation soil sample was collected at the wellhead excavation. Change of directions were field-screened via hand auger. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
