Areas of the location not needed for production, or no longer in use have been reduced and reclaimed. If annual undesirable plant species and/or noxious annual weeds (cheatgrass) are present, they are not evident due to winter season and snow cover. A full vegetation assessment will be performed during the growing season.
