**Description of Alleged Violation:**

Pursuant to Rule 419.c., your entity was required to perform an annual Bradenhead Test on certain wells and submit the data on a Form 17, Bradenhead Test Report, within 10 days after the test.

As of today's date, COGCC Records indicate that your entity has not filed a Form 17 for the required wells, for the year of 2021, reporting that a Bradenhead Test was conducted, violating Rule 419.c.

Operator shall review its records to verify if any Forms or Notices related to Bradenhead testing were late or are still outstanding for these Wells. Operator shall submit any delinquent forms, notices, or reports; and correct any incomplete or inaccurate reports.

Where Operator has failed to perform a Bradenhead Test in 2021, a test shall be performed by the Corrective Action Date listed. Pursuant to Rule 420, Operator is required to submit the results of BH tests to COGCC within 10 days of completion. Operator shall submit such results by filing a Bradenhead Test Report, Form 17, which shall include a wellbore diagram if not previously submitted or if the wellbore configuration has changed, and the results of any gas and liquid analysis, if sampled.

### PENALTY

Penalties for violations alleged in this NOAV will be calculated pursuant to Rule 525, with daily penalties accruing pursuant to Section 34-60-121(1), C.R.S.

### ANSWER
